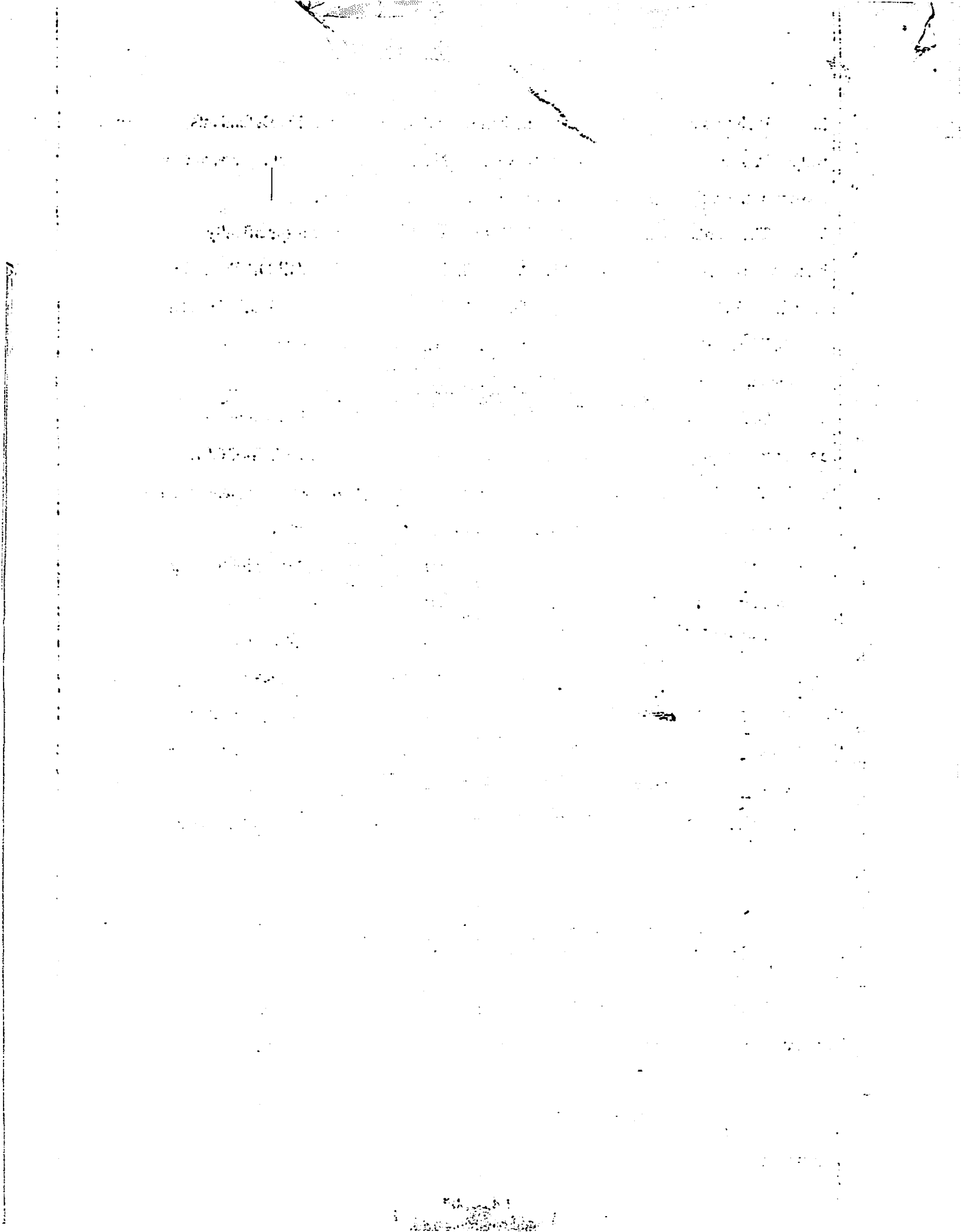

2 (a) General. A public accommodation shall take those steps that may be
3 necessary to ensure that no individual with a disability is excluded, denied
4 services, segregated or otherwise treated differently than other individuals
5 because of the absence of auxiliary aids and services, unless the public
6 accommodation can demonstrate that taking those steps would
7 fundamentally alter the nature of the goods, services, facilities, privileges,
8 advantages, or accommodations being offered or would result in an undue
9 burden, i.e., significant difficulty or expense.

10 (b) Examples. The term "auxiliary aids and services" includes:

11 (1) Qualified interpreters, notetakers, computer-aided transcription
12 services, written materials, telephone handset amplifiers, assistive
13 listening devices, assistive listening systems, telephones compatible with
14 hearing aids, closed caption decoders, open and closed captioning,
15 telecommunications devices for deaf persons (TDD's), videotext displays,
16 or other effective methods of making aurally delivered materials available
17 to individuals with hearing impairments;

18 (2) Qualified readers, taped texts, audio recordings, Brailled materials,
19 large print materials, or other effective methods of making visually
20 delivered materials available to individuals with visual impairments;

21 (3) Acquisition or modification of equipment or devices; and

22 (4) Other similar services and actions.

23 (c) Effective communication. A public accommodation shall furnish
24 appropriate auxiliary aids and services where necessary to ensure effective
25 communication with individuals with disabilities.

1 Defendants failed to comply with Title 28, part 36.303 of Code of Federal Regulations as
2 it failed to provide Qualified readers, taped texts, audio recordings, Brailled materials, or
3 large print materials. Further, Defendants failed to remove architectural barriers.

4 8. Plaintiff's Member and Plaintiff(s) have physical impairments because their
5 conditions affect one or more of the following body systems: neurological,
6 musculoskeletal, special sense organs, and/or cardiovascular. Further, Plaintiff's
7 Member and Plaintiff(s) said physical impairments substantially limits one or more of the
8 following major life activities. In addition, Plaintiff's Member and Plaintiff(s) cannot
9 perform one or more of the said major life activities in the manner, speed, and duration
10 when compared to the average person. Moreover, Plaintiff's Member and Plaintiff(s) has
11 a history of or has been classified as having a physical impairment as required by 42
12 U.S.C. § 12102(2)(A).

13 9. Plaintiff's Members expressly intend to patronize the establishment and the
14 property that is the subject of this Complaint in the immediate future.

15 10. Plaintiff's Member was deterred from patronizing the facility.

11 U.S.C. §12182.

13 15. Based on the facts stated above, Defendants discriminated against Plaintiffs as it
14 is discriminatory to afford an individual or class of individuals, on the basis of a disability
15 or disabilities of such individual or class, directly, or through contractual, licensing, or
16 other arrangements with the opportunity to participate in or benefit from a good, service,
17 facility, privilege, advantage, or accommodation that is not equal to that afforded to other
18 individuals in violation of 42 U.S.C. §12182.

19 Claim IV

20 16. Based on the facts stated above, Defendants discriminated against Plaintiffs as it
21 is discriminatory to provide an individual or class of individuals, on the basis of a
22 disability or disabilities of such individual or class, directly, or through contractual,
23 licensing, or other arrangements with a good, service, facility, privilege, advantage, or
24 accommodation that is different or separate from that provided to other individuals.

20 Defendant failed to demonstrate that the removal of a barrier is not readily achievable,
21 and made such goods, services, facilities, privileges, advantages, or accommodations
22 available through alternative methods in a segregated manner in violation of 42 U.S.C.
23 §12182.

9 **CLAIM I: Denial Of Full And Equal Access**

10 24. Based on the facts plead above and elsewhere in this complaint, Plaintiff's
11 Member and Plaintiff(s) was denied full and equal access to Defendants' goods, services,
12 facilities, privileges, advantages, or accommodations within a public accommodation
13 owned, leased, and/or operated by Defendants as required by Civil Code Sections 54 and
14 54.1.

15 **CLAIM II: Failure To Modify Practices, Policies And Procedures**

16 25. Based on the facts plead at ¶¶ 6-16 above and elsewhere herein this complaint,
17 Defendants failed and refused to provide a reasonable alternative by modifying its
18 practices, policies, and procedures in that they failed to have a scheme, plan, or design to
19 assist Plaintiffs and/or others similarly situated in entering and utilizing Defendants'
20 services as required by Civil Code § 54.1. Thus, Plaintiff's Member and Plaintiff(s) were
21 subjected to discrimination in violation of Civil Code § 54.1.

22 **CLAIM III: Violation Of The Unruh Act**

23 26. Based on the facts plead above and elsewhere herein this complaint and because
24 Defendants violated the Civil Code § 51 by failing to comply with 42 United States Code
25 § 12182(b)(2)(A)(iv) and 42 U.S.C. § 12183(a)(2), Defendants did and continue to
26 knowingly discriminate against Plaintiffs and persons similarly situated in violation of
27 Civil Code §§ 51, 52, and 54.1. Plaintiffs allege the access violations alleged here are so

1 obvious as to implicate at least a prima facie case of discriminatory intent.

2 27. Based on the facts plead above. Claims I, II, and III of Plaintiffs' Second Cause
3 Of Action above, and the facts elsewhere herein this complaint, Plaintiffs will suffer
4 irreparable harm unless Defendants are ordered to remove architectural, non-
5 architectural, and communication barriers at Defendants' public accommodation.
6 Plaintiffs allege that Defendants' discriminatory conduct is capable of repetition, and this
7 discriminatory repetition adversely impacts Plaintiffs and a substantial segment of the
8 disability community. Plaintiffs allege there is a state and national public interest in
9 requiring accessibility in places of public accommodation. Plaintiffs have no adequate
10 remedy at law to redress the discriminatory conduct of Defendants. Plaintiffs desire to
11 return to Defendants' places of business in the immediate future. Accordingly, the
12 Plaintiffs allege that a structural or mandatory injunction is necessary to enjoin
13 compliance with state civil rights laws enacted for the benefit of individuals with
14 disabilities.

15 28. Wherefore, Plaintiffs pray for damages and relief as hereinafter stated.



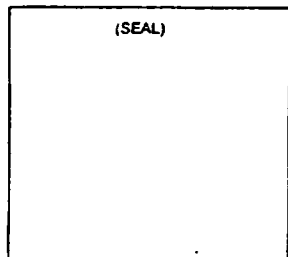
