Plaintiff is informed, believes and thereon alleges that Defendants are, and, at all times mentioned herein, were, a business or corporation or franchise organized and existing and/or doing business under the laws of the State of California. Plaintiff is informed and believes and thereon alleges that Defendants L.A. MEDICAL CENTER, LLC; KINGSLEY PHARMA II are the owner, operator, and/or lessor/lessee of the real property and the public accommodation located thereon at the Property Address: 3663 W 6TH ST, LOS ANGELES, CA 90020; Assessor's Parcel Number: 5503-024-001. Defendant L.A. MEDICAL CENTER, LLC c/o Registered Agent: MARTIN B. PARK, located at 3663 WEST 6TH STREET SUITE 111, LOS ANGELES, CA 90020. Defendant KINGSLEY PHARMA II is located at 3663 W 6TH ST # 102, LOS ANGELES, CA 90020-3026 c/o Contact Name: KIM KU.

1 2. The words Plaintiff and Plaintiffs as used herein specifically include JON CARPENTER.

2 3. Defendants Does 1 through 10, were at all times relevant herein subsidiaries, employers,
3 employees, agents, of Defendants L.A. MEDICAL CENTER, LLC; KINGSLEY PHARMA II.
4 Plaintiff is ignorant of the true names and capacities of Defendants sued hereinafter as Does 1 through
5 10, inclusive, and therefore sues these Defendants by such fictitious names. Plaintiff will pray
6 leave of the court to amend this complaint to allege the true names and capacities of the Does
7 when ascertained.

8 4. Plaintiff is informed and believes, and thereon alleges, that Defendants and each of them
9 herein were, at all times relevant to the action, the owner, lessor, lessee, franchiser, franchisee,
10 general partner, limited partner, agent, employee, representing partner, or joint venturer of the
11 remaining Defendants and were acting within the course and scope of that relationship. Plaintiff
12 is further informed and believe, and thereon allege, that each of the Defendants herein gave
13 consent to, ratified, and/or authorized the acts alleged herein to each of the remaining Defendants.

14 **CONCISE SET OF FACTS**

15 5. Plaintiff JON CARPENTER (hereinafter "Plaintiff") has physical impairments and due to
16 these impairments he has learned to successfully operate a wheelchair for mobility. Plaintiff said
17 physical impairments substantially limit one or more of the following major life activities
18 including but not limited to: walking.

19 6. Plaintiff has physical impairments because their conditions affect one or more of the
20 following body systems: neurological, musculoskeletal, special sense organs, and/or
21 cardiovascular. Further, Plaintiff said physical impairments substantially limits one or more of
22 the following major life activities. In addition, Plaintiff cannot perform one or more of the said
23 major life activities in the manner, speed, and duration when compared to the average person.
24 Moreover, Plaintiff has a history of or has been classified as having a physical impairment as
25 required by 42 U.S.C. § 12102(2)(A).

26 7. On December 7, 2007, Plaintiff JON CARPENTER wanted to visit Defendants' public
27 accommodation facilities located at Property Address: 3663 W 6TH ST, LOS ANGELES, CA
28

1 90020; Assessor's Parcel Number: 5503-024-001 to utilize their goods and/or services. When
2 Plaintiff JON CARPENTER patronized Defendants' public accommodation facilities, he was
3 unable to use and/or had difficulty using the public accommodations' facilities including but not
4 limited to the barriers to access listed herein and said facilities were not accessible because they
5 failed to comply with ADA Access Guidelines For Buildings and Facilities (hereafter referred to
6 as "ADAAG" and codified in 28 C.F.R. Part 36, App. A) and/or California's Title 24 Building
7 Code Requirements. Defendants failed to remove barriers to equal access within their public
8 accommodation facilities as required.

9 8. Plaintiff JON CARPENTER was deterred from visiting the property due to said access
10 barriers as listed herein to the present Complaint at Defendants' public accommodation facilities
11 located on the Property and/or has knowledge of said access barriers and is presently deterred
12 from accessing the public accommodation. Plaintiff alleges that these known barriers to access
13 are not an exhaustive list of the barriers to access that exist at Defendants' facilities.

14 9. Defendants failed to provide auxiliary aids and services that are necessary to ensure equal
15 access to the goods, services, privileges, or accommodations that it offers. Title 28, part 36.303
16 of Code of Federal Regulations states:

17 (a) General. A public accommodation shall take those steps that may be necessary to ensure that
18 no individual with a disability is excluded, denied services, segregated or otherwise treated
19 differently than other individuals because of the absence of auxiliary aids and services, unless the
20 public accommodation can demonstrate that taking those steps would fundamentally alter the
21 nature of the goods, services, facilities, privileges, advantages, or accommodations being offered
22 or would result in an undue burden, i.e., significant difficulty or expense.

23 (b) Examples. The term "auxiliary aids and services" includes:

24 (1) Qualified interpreters, notetakers, computer-aided transcription services, written
25 materials, telephone handset amplifiers, assistive listening devices, assistive listening
26 systems, telephones compatible with hearing aids, closed caption decoders, open and
27 closed captioning, telecommunications devices for deaf persons (TDD's), videotext
28

1 displays, or other effective methods of making aurally delivered materials available to
2 individuals with hearing impairments;

3 (2) Qualified readers, taped texts, audio recordings, Brailled materials, large print
4 materials, or other effective methods of making visually delivered materials available to
5 individuals with visual impairments;

6 (3) Acquisition or modification of equipment or devices; and

7 (4) Other similar services and actions.

8 (c) Effective communication. A public accommodation shall furnish appropriate auxiliary aids
9 and services where necessary to ensure effective communication with individuals with
10 disabilities.

11 10. Plaintiff can prove these barriers as Plaintiff conducted a preliminary survey of
12 Defendants' facility. Plaintiff specifically alleges that Defendants knew, to a substantial
13 certainty, that the architectural barriers precluded equal access. First, Plaintiff will prove that
14 Defendants had actual knowledge that the architectural barriers precluded equal access and that
15 the noncompliance with ADAAG as to accessible entrances was intentional. Second, due to the
16 abundance of ADA information and constant news covers of ADA lawsuits, Defendants had
17 actual knowledge of the ADA and decided deliberately not to remove architectural barriers.
18 Third, Defendants have no plans to remodel. Fourth, Defendants had actual knowledge of ADA
19 given all the ADA public awareness campaigns, the abundance of free ADA information and the
20 media's constant ADA coverage. Fifth, a human being acting for the defendants made a
21 conscious decision as to how to proceed given the presence of the architectural barriers. Plaintiff
22 alleges any alternative methods preclude integration of disabled patrons, as it requires them to use
23 second-class facilities. Also, expert testimony will show the facility contained inaccessible
24 features. Plaintiff alleges businesses often state that they have few customers with disabilities.
25 Plaintiff alleges such customers avoid patronizing inaccessible businesses and are deterred from
26 patronizing such businesses.

27 11. For example, there is no van accessible parking. This violation deterred the Plaintiff's
28

1 access to the pharmacy. In addition, the property failed to have disability tow away signs at the
2 parking lot entrance.

3 12. Plaintiff intends to return to Defendants' public accommodation facilities in the immediate
4 future. Plaintiff was deterred and is presently deterred from returning due to his knowledge of the
5 barriers to access that exist at Defendants' facilities.

6 13. Pursuant to federal and state law, Defendants are required to remove barriers to their
7 existing facilities. Further, Defendants had actual knowledge of their barrier removal duties
8 under the Americans with Disabilities Act and the Civil Code before January 26, 1992. Also,
9 Defendants should have known that individuals with disabilities are not required to give notice to
10 a governmental agency before filing suit alleging Defendants failed to remove architectural
11 barriers.

12 14. Plaintiff believes and herein alleges Defendants' facilities have access violations not
13 directly experienced by Plaintiff which would preclude or limit access by Plaintiff potentially
14 including but not limited to violations of the ADA, ADA Accessibility Guidelines (Codified in 28
15 C.F.R. Part 36, App. A) and Title 24 of the California Building Code. Plaintiff alleges
16 Defendants are required to utilize the ADA checklist for Readily Achievable Barrier Removal
17 approved by the United States Department of Justice and created by Adaptive Environments.
18 Plaintiff is entitled to injunctive relief to remove all barriers to access that are related to his
19 disability even those barriers that are only known to exist but are not directly experienced by
20 plaintiff. *Doran v 7-Eleven Inc*, 2007 U.S.App.Lexis 26143 (9th Cir 2007).

21 15. Based on these facts, Plaintiff alleges he was discriminated against each time he
22 patronized and/or was deterred from patronizing Defendants' facilities. Plaintiff was extremely
23 upset due to Defendants' conduct.

24 16. Plaintiff is not required to provide notice to the defendants prior to filing a complaint
25 and/or to recover attorney fees and costs. *Botosan v. Paul McNally Realty*, 216 F.3d 827, 832
26 (9th Cir 2000). *Skaff v Meridien*, 2007 U.S. App. LEXIS 25516 (9th Cir 2007).

27 **WHAT CLAIMS ARE PLAINTIFF ALLEGING AGAINST EACH NAMED**

1 **DEFENDANT**

2 17. Defendants L.A. MEDICAL CENTER, LLC; KINGSLEY PHARMA II and Does 1
3 through 10 will be referred to collectively hereinafter as "Defendants."

4 18. Plaintiff avers that the Defendants are liable for the following claims as alleged below:

5 **DISCRIMINATORY PRACTICES IN PUBLIC ACCOMMODATIONS**

6 **FIRST CAUSE OF ACTION AGAINST ALL DEFENDANTS- Claims Under The Americans**

7 **With Disabilities Act Of 1990**

8 **Claim I**

9 19. Based on the facts stated above, Defendants discriminated against Plaintiff on the basis of
10 disability in the full and equal enjoyment of the goods, services, facilities, privileges, advantages,
11 or accommodations of any place of public accommodation as Defendants own, lease (or lease
12 to), or operate a place of public accommodation in violation of 42 U.S.C. §12182.

13 **Claim II**

14 20. Based on the facts stated above, Defendants discriminated against Plaintiff directly, or
15 through contractual, licensing, or other arrangements, to a denial of the opportunity of the
16 individual or class to participate in or benefit from the goods, services, facilities, privileges,
17 advantages, or accommodations of an entity in violation of 42 U.S.C. §12182.

18 **Claim III**

19 21. Based on the facts stated above, Defendants discriminated against Plaintiff as it is
20 discriminatory to afford an individual or class of individuals, on the basis of a disability or
21 disabilities of such individual or class, directly, or through contractual, licensing, or other
22 arrangements with the opportunity to participate in or benefit from a good, service, facility,
23 privilege, advantage, or accommodation that is not equal to that afforded to other individuals in
24 violation of 42 U.S.C. §12182.

25 **Claim IV**

26 22. Based on the facts stated above, Defendants discriminated against Plaintiff as it is
27 discriminatory to provide an individual or class of individuals, on the basis of a disability or
28

1 disabilities of such individual or class, directly, or through contractual, licensing, or other
2 arrangements with a good, service, facility, privilege, advantage, or accommodation that is
3 different or separate from that provided to other individuals.

4 Claim V

5 23. Based on the facts stated above, Defendants discriminated against Plaintiff as Defendants
6 failed to afford to an individual with a disability in the most integrated setting appropriate to
7 the needs of the individual in violation of 42 U.S.C. §12182.

8 Claim VI

9 24. Based on the facts stated above, Defendants discriminated against Plaintiff as Defendants
10 utilized standards or criteria or methods of administration that have the effect of discriminating on
11 the basis of disability; or that perpetuate the discrimination of others who are subject to common
12 administrative control in violation of 42 U.S.C. §12182.

13 Claim VII

14 25. Based on the facts stated above, Defendants discriminated against Plaintiff as it is
15 discriminatory to exclude or otherwise deny equal goods, services, facilities, privileges,
16 advantages, accommodations, or other opportunities to an individual or entity because of the
17 known disability of an individual with whom the individual or entity is known to have a
18 relationship or association in violation of 42 U.S.C. §12182. See *Niece v. Fitzner* 922 F. Supp.
19 1208 (1996)

20 Claim VIII

21 26. Based on the facts stated above, Defendants discriminated against Plaintiff as Defendants
22 engaged in the specific prohibitions as stated in 42 U.S.C. §12182.

23 Claim IX

24 27. Based on the facts stated above, Defendants discriminated against Plaintiff as Defendant
25 failed to demonstrate that the removal of a barrier is not readily achievable, and made such goods,
26 services, facilities, privileges, advantages, or accommodations available through alternative
27 methods in a segregated manner in violation of 42 U.S.C. §12182. Plaintiff is entitled to
28

1 injunctive relief to remove all barriers to access that are related to his disability even those
2 barriers that are only known to exist but are not directly experienced by plaintiff. *Doran v 7-*
3 *Eleven Inc*, 2007 U.S.App.Lexis 26143 (9th Cir 2007).

4 Claim X

5 28. Based on the facts stated above, Defendants discriminated against Plaintiff as Defendants
6 altered the use of their establishment in a manner that affected or could have affected the usability
7 of the facility or part thereof and failed to make alterations in such a manner that, to the maximum
8 extent feasible, the altered portions of the facility are readily accessible to and usable by
9 individuals with disabilities in violation of 42 U.S.C. §12183.

10 29. WHEREFORE, Plaintiff pray for judgment and relief as hereinafter set forth.

11
12 SECOND CAUSE OF ACTION AGAINST ALL DEFENDANTS - **CLAIMS UNDER**
13 **CALIFORNIA ACCESSIBILITY LAWS**

14 CLAIM I: **Denial Of Full And Equal Access**

15 30. Based on the facts plead above and elsewhere in this complaint, Plaintiff was denied full
16 and equal access to Defendants' goods, services, facilities, privileges, advantages, or
17 accommodations within a public accommodation owned, leased, and/or operated by Defendants
18 as required by Civil Code Sections 54 and 54.1.

19 CLAIM II: **Failure To Modify Practices, Policies And Procedures**

20 31. Based on the facts plead above and elsewhere herein this complaint, Defendants failed and
21 refused to provide a reasonable alternative by modifying its practices, policies, and procedures in
22 that they failed to have a scheme, plan, or design to assist Plaintiff and/or others similarly situated
23 in entering and utilizing Defendants' services as required by Civil Code § 54.1. Thus, Plaintiff
24 was subjected to discrimination in violation of Civil Code § 54.1.

25 CLAIM III: **Violation Of The Unruh Act**

26 32. Based on the facts plead above and elsewhere herein this complaint and because
27 Defendants violated the Civil Code § 51 by failing to comply with 42 United States Code §
28 12182(b)(2)(A)(iv) and 42 U.S.C. § 12183(a)(2), Defendants did and continue to knowingly

1 discriminate against Plaintiff and persons similarly situated in violation of Civil Code §§ 51, 52,
2 and 54.1. Plaintiff alleges the access violations alleged here are so obvious as to implicate at least
3 a prima facie case of discriminatory intent.

4 33. Based on the facts plead above, Claims I, II, and III of Plaintiffs' Second Cause Of
5 Action above, and the facts elsewhere herein this complaint, Plaintiff will suffer irreparable harm
6 unless Defendants are ordered to remove architectural, non-architectural, and communication
7 barriers at Defendants' public accommodation. Plaintiff alleges that Defendants' discriminatory
8 conduct is capable of repetition, and this discriminatory repetition adversely impacts Plaintiff and
9 a substantial segment of the disability community. Plaintiff alleges there is a state and national
10 public interest in requiring accessibility in places of public accommodation. Plaintiff has no
11 adequate remedy at law to redress the discriminatory conduct of Defendants. Plaintiff desires to
12 return to Defendants' places of business in the immediate future. Accordingly, the Plaintiff
13 alleges that a structural or mandatory injunction is necessary to enjoin compliance with state civil
14 rights laws enacted for the benefit of individuals with disabilities.

15 34. Wherefore, Plaintiff prays for damages and relief as hereinafter stated.

28 Civil Code § 51, Title 24 of the California Building Code, ADA, and ADA Accessibility

1 Guidelines (Codified in 28 C.F.R. Part 36, App. A);

2 D. In the alternative to the damages pursuant to Cal. Civil Code § 52 in Paragraph C above,
3 for \$1,000 in damages pursuant to Cal. Civil Code § 54.3 for each and every offense of Civil
4 Code § 54.1, Title 24 of the California Building Code, ADA, and ADA Accessibility Guidelines;

5 E. For treble damages pursuant to Cal. Civil Code §§ 52(a) or 54.3(a);

6
7 F. For attorneys fees pursuant to 42 U.S.C. § 1988, 42 U.S.C. § 12205, and Cal. Civil Code
8 § 52; 54.3;


