2. Plaintiffs are further informed and believe and thereon allege that Defendants, CVS Drugs; RAVEN ENTERPRISES LP; SMULL, LESTER SMULL TRUST ETAL,

1 are the owners, operators, and/or lessors of the real property, as well as the business
2 operated thereon.

3 3. The words "Plaintiffs" and "Plaintiff's Member" as used herein specifically
4 include the organization and TRIPPLE AAA ASSOCIATION FOR CHILDREN AND
5 ADULTS WITH DEVELOPMENTAL DISABILITIES, SUING ON BEHALF OF ITS
6 MEMBERS, JAMES H. COHAN; and persons associated with its Members who
7 accompanied Members to Defendants' facilities.

8 4. Defendants Does 1 through 10, were at all times relevant herein subsidiaries,
9 employers, employees, agents, of Defendants CVS Drugs; RAVEN ENTERPRISES LP;
10 SMULL, LESTER SMULL TRUST ETAL. Plaintiffs are ignorant of the true names and
11 capacities of Defendants sued herein as Does 1 through 10, inclusive, and therefore sues
12 these Defendants by such fictitious names. Plaintiffs will pray leave of the court to
13 amend this complaint to allege the true names and capacities of the Does when
14 ascertained.

15 5. Plaintiffs are informed and believe, and thereon allege, that Defendants and each
16 of them herein were, at all times relevant to the action, the owner, lessor, lessee,
17 franchiser, franchisee, general partner, limited partner, agent, employee, representing
18 partner, or joint venturer of the remaining Defendants and were acting within the course
19 and scope of that relationship. Plaintiffs are further informed and believe, and thereon
20 allege, that each of the Defendants herein gave consent to, ratified, and/or authorized the
21 acts alleged herein to each of the remaining Defendants.

24 **CONCISE SET OF FACTS**

25 6. Plaintiff has an impairment.

26 7. Defendants failed to provide auxiliary aids and services that are necessary to
27 ensure equal access to the goods, services, privileges, or accommodations that it offers.

28 Title 28, part 36.303 of Code of Federal Regulations states:

1 (a) General. A public accommodation shall take those steps that may be
2 necessary to ensure that no individual with a disability is excluded, denied
3 services, segregated or otherwise treated differently than other individuals
4 because of the absence of auxiliary aids and services, unless the public
5 accommodation can demonstrate that taking those steps would
6 fundamentally alter the nature of the goods, services, facilities, privileges,
7 advantages, or accommodations being offered or would result in an undue
8 burden, i.e., significant difficulty or expense.

9 (b) Examples. The term "auxiliary aids and services" includes:

10 (1) Qualified interpreters, notetakers, computer-aided transcription
11 services, written materials, telephone handset amplifiers, assistive
12 listening devices, assistive listening systems, telephones compatible with
13 hearing aids, closed caption decoders, open and closed captioning,
14 telecommunications devices for deaf persons (TDD's), videotext displays,
15 or other effective methods of making aurally delivered materials available
16 to individuals with hearing impairments;

17 (2) Qualified readers, taped texts, audio recordings, Brailled materials,
18 large print materials, or other effective methods of making visually
19 delivered materials available to individuals with visual impairments;

20 (3) Acquisition or modification of equipment or devices; and

21 (4) Other similar services and actions.

22 (c) Effective communication. A public accommodation shall furnish
23 appropriate auxiliary aids and services where necessary to ensure effective
24 communication with individuals with disabilities.
25

26 Defendants failed to comply with Title 28, part 36.303 of Code of Federal Regulations as
27 it failed to provide Qualified readers, taped texts, audio recordings, Brailled materials, or
28 large print materials. Further, Defendants failed to remove architectural barriers.

1 8. Plaintiff's Member and Plaintiff(s) have physical impairments because their
2 conditions affect one or more of the following body systems: neurological,
3 musculoskeletal, special sense organs, and/or cardiovascular. Further, Plaintiff's
4 Member and Plaintiff(s) said physical impairments substantially limits one or more of the
5 following major life activities. In addition, Plaintiff's Member and Plaintiff(s) cannot
6 perform one or more of the said major life activities in the manner, speed, and duration
7 when compared to the average person. Moreover, Plaintiff's Member and Plaintiff(s) has
8 a history of or has been classified as having a physical impairment as required by 42
9 U.S.C. § 12102(2)(A).

10 9. Plaintiff's Members expressly intend to patronize the establishment and the
11 property that is the subject of this Complaint in the immediate future.

12 10. Plaintiff's Member was deterred from patronizing the facility.

14 **WHAT CLAIMS ARE PLAINTIFFS ALLEGING AGAINST EACH NAMED**
15 **DEFENDANT**

16 11. Defendants CVS Drugs; RAVEN ENTERPRISES LP; SMULL, LESTER
17 SMULL TRUST ETAL; and Does 1 through 10 will be referred to collectively
18 hereinafter as "Defendants."

19 12. Plaintiffs aver that the Defendants are liable for the following claims as alleged
20 below:

21
22 **DISCRIMINATORY PRACTICES IN PUBLIC ACCOMMODATIONS**

23 **FIRST CAUSE OF ACTION AGAINST ALL DEFENDANTS- Claims Under The**
24 **Americans With Disabilities Act Of 1990**

25
26 **Claim I**

27 13. Based on the facts stated above, Defendants discriminated against Plaintiffs on the
28 basis of disability in the full and equal enjoyment of the goods, services, facilities,

1 privileges, advantages, or accommodations of any place of public accommodation as
2 Defendants own, lease (or lease to), or operate a place of public accommodation in
3 violation of 42 U.S.C. §12182.

4 Claim II

5 14. Based on the facts stated above, Defendants discriminated against Plaintiffs
6 directly, or through contractual, licensing, or other arrangements, to a denial of the
7 opportunity of the individual or class to participate in or benefit from the goods, services,
8 facilities, privileges, advantages, or accommodations of an entity in violation of 42
9 U.S.C. §12182.

10 Claim III

11 15. Based on the facts stated above, Defendants discriminated against Plaintiffs as it
12 is discriminatory to afford an individual or class of individuals, on the basis of a disability
13 or disabilities of such individual or class, directly, or through contractual, licensing, or
14 other arrangements with the opportunity to participate in or benefit from a good, service,
15 facility, privilege, advantage, or accommodation that is not equal to that afforded to other
16 individuals in violation of 42 U.S.C. §12182.

17 Claim IV

18 16. Based on the facts stated above, Defendants discriminated against Plaintiffs as it
19 is discriminatory to provide an individual or class of individuals, on the basis of a
20 disability or disabilities of such individual or class, directly, or through contractual,
21 licensing, or other arrangements with a good, service, facility, privilege, advantage, or
22 accommodation that is different or separate from that provided to other individuals.

23 Claim V

24 17. Based on the facts stated above, Defendants discriminated against Plaintiffs as
25 Defendants failed to afforded to an individual with a disability in the most integrated
26 setting appropriate to the needs of the individual in violation of 42 U.S.C. §12182.

27 Claim VI

1 18. Based on the facts stated above, Defendants discriminated against Plaintiffs as
2 Defendants utilized standards or criteria or methods of administration that have the effect
3 of discriminating on the basis of disability; or that perpetuate the discrimination of others
4 who are subject to common administrative control in violation of 42 U.S.C. §12182.

5 Claim VII

6 19. Based on the facts stated above, Defendants discriminated against Plaintiffs as it
7 is discriminatory to exclude or otherwise deny equal goods, services, facilities, privileges,
8 advantages, accommodations, or other opportunities to an individual or entity because of
9 the known disability of an individual with whom the individual or entity is known to have
10 a relationship or association in violation of 42 U.S.C. §12182. See Niece v. Fitzner 922 F.
11 Supp. 1208 (1996)

12 Claim VIII

13 20. Based on the facts stated above, Defendants discriminated against Plaintiffs as
14 Defendants engaged in the specific prohibitions as stated in 42 U.S.C. §12182.

15 Claim IX

16 21. Based on the facts stated above, Defendants discriminated against Plaintiffs as
17 Defendant failed to demonstrate that the removal of a barrier is not readily achievable,
18 and made such goods, services, facilities, privileges, advantages, or accommodations
19 available through alternative methods in a segregated manner in violation of 42 U.S.C.
20 §12182.

21 Claim X

22 22. Based on the facts stated above, Defendants discriminated against Plaintiffs as
23 Defendants altered the use of their establishment in a manner that affected or could have
24 affected the usability of the facility or part thereof and failed to make alterations in such a
25 manner that, to the maximum extent feasible, the altered portions of the facility are
26 readily accessible to and usable by individuals with disabilities, including individuals
27 who use wheelchairs in violation of 42 U.S.C. §12183.
28

1 Plaintiffs allege that Defendants' discriminatory conduct is capable of repetition, and this
2 discriminatory repetition adversely impacts Plaintiffs and a substantial segment of the
3 disability community. Plaintiffs allege there is a state and national public interest in
4 requiring accessibility in places of public accommodation. Plaintiffs have no adequate
5 remedy at law to redress the discriminatory conduct of Defendants. Plaintiffs desire to
6 return to Defendants' places of business in the immediate future. Accordingly, the
7 Plaintiffs allege that a structural or mandatory injunction is necessary to enjoin
8 compliance with state civil rights laws enacted for the benefit of individuals with
9 disabilities.

10 28. Wherefore, Plaintiffs pray for damages and relief as hereinafter stated.
11

INSTRUCTIONS ON HOW TO COMPLETE THE COVER SHEET

To Plaintiffs and Others Filing First Papers. If you are filing a first paper (for example, a complaint) in a civil case, you **must** complete and file, along with your first paper, the *Civil Case Cover Sheet* contained on page 1. This information will be used to compile statistics about the types and numbers of cases filed. You must complete items 1 through 6 on the sheet. In item 1, you must check **one** box for the case type that best describes the case. If the case fits both a general and a more specific type of case listed in item 1, check the more specific one. If the case has multiple causes of action, check the box that best indicates the **primary** cause of action. To assist you in completing the sheet, examples of the cases that belong under each case type in item 1 are provided below. A cover sheet must be filed only with your initial paper. Failure to file a cover sheet with the first paper filed in a civil case may subject a party, its counsel, or both to sanctions under rules 2.30 and 3.220 of the California Rules of Court.

To Parties in Rule 3.740 Collections Cases. A "collections case" under rule 3.740 is defined as an action for recovery of money owed in a sum stated to be certain that is not more than \$25,000, exclusive of interest and attorney's fees, arising from a transaction in which property, services, or money was acquired on credit. A collections case does not include an action seeking the following: (1) tort damages, (2) punitive damages, (3) recovery of real property, (4) recovery of personal property, or (5) a prejudgment writ of attachment. The identification of a case as a rule 3.740 collections case on this form means that it will be exempt from the general time-for-service requirements and case management rules, unless a defendant files a responsive pleading. A rule 3.740 collections case will be subject to the requirements for service and obtaining a judgment in rule 3.740.

To Parties in Complex Cases. In complex cases only, parties must also use the *Civil Case Cover Sheet* to designate whether the case is complex. If a plaintiff believes the case is complex under rule 3.400 of the California Rules of Court, this must be indicated by completing the appropriate boxes in items 1 and 2. If a plaintiff designates a case as complex, the cover sheet must be served with the complaint on all parties to the action. A defendant may file and serve no later than the time of its first appearance a joinder in the plaintiff's designation, a counter-designation that the case is not complex, or, if the plaintiff has made no designation, a designation that the case is complex.
